

RESOLUTION R-2882

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KIRKLAND AUTHORIZING THE MAYOR TO SIGN ON BEHALF OF THE CITY OF KIRKLAND THAT CERTAIN AGREEMENT WITH THE WASHINGTON STATE URBAN ARTERIAL BOARD FOR PRELIMINARY DESIGN WORK ON 124TH AVENUE N.E. - NORTHEAST 116TH TO NORTHEAST 124TH.

Whereas, there are available State of Washington Urban Arterial funds allocable to the City of Kirkland for preliminary design engineering for improvements to 124th Avenue N.E. between Northeast 116th Street and Northeast 124th Street; and

Whereas, the Washington State Urban Arterial Board has submitted to the City of Kirkland its project agreement for preliminary proposal authorizing allocation of \$24,900 to be used for design of improvements to 124th Avenue N.E. within the City of Kirkland

Now, therefore be it resolved by the City Council of the City of Kirkland as follows:

Section 1. The mayor of the City of Kirkland is hereby authorized and directed to sign on behalf of the City of Kirkland that certain agreement with the Washington State Urban Arterial Board Project No. 81-1-111(08) copy of which is attached to the original of this resolution and by this reference incorporated herein.

IN CONSIDERATION of the allocation by the Urban Arterial Board of urban arterial trust account funds to the project and in the amount set out above, the city or county hereby agrees that as condition precedent to payment of any urban arterial trust account funds allocated at any time to the above referenced project, it accepts and will comply with the terms of this agreement, including the terms and conditions set forth in RCW 47.28; the applicable rules and regulations of the Urban Arterial Board, and all representations made to the Urban Arterial Board upon which the fund allocation was based; all of which are familiar to and within the knowledge of the city or county and incorporated herein and made a part of this agreement, although not attached. The officer of the city or county, by his signature below, hereby certifies on behalf of the city or county that local matching funds and other funds represented to be committed to the project will be available as necessary to implement the projected development of the project as set forth in the PRELIMINARY proposal prospectus, acknowledges that funds hereby authorized are for the development of the construction proposal as defined by Chapter 126, Laws of 1973, 1st Ex. Sess., and acknowledges that this project is an accelerated development project as provided for by Section 4, Chapter 317, Laws of 1981, and is subject to immediate cancellation by the Urban Arterial Board if the project's development is delayed in relation to the schedule presented to, and accepted by, the Board at the time of project authorization.

IN CONSIDERATION of the promises and performance of the stated conditions by the city or county, the Urban Arterial Board hereby agrees to reimburse the city or county from urban arterial trust funds allocated, and not otherwise for its reimbursable costs during the ensuing quarter year not to exceed the amount above specified. Such obligation to reimburse urban arterial trust funds extends only to project costs incurred after the date of the Urban Arterial Board's allocation of funds and authorization to proceed with the project.
