

RESOLUTION NO. R -2907

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KIRKLAND APPROVING SUPPLEMENT NO. 1 TO WASHINGTON STATE DEPARTMENT OF TRANSPORTATION CITY/COUNTY AGREEMENT NO. FAM 438 FOR THE IMPROVEMENT OF N.E. 124th STREET BETWEEN 116th AVENUE NORTHEAST AND 132nd AVENUE NORTHEAST AND AUTHORIZING THE MAYOR TO SIGN SAME.

Whereas, the City of Kirkland heretofore by Resolution No. R-2770 authorized the Mayor to sign on behalf of the City of Kirkland, a Washington State Department of Transportation City/County Agreement, providing federal funding for improvements to be made on N.E. 124th Street between 116th Avenue Northeast and 132nd Avenue Northeast being Agreement No. FAM 438 for project No. M-2412(1); and

Whereas, since the execution of that Agreement there has been an increase in the estimated cost for the improvement including preliminary engineering and construction, necessitating an amendment to said Agreement,

Now, therefore, be it resolved by the City Council of the City of Kirkland as follows:


Section 1. The Mayor is hereby authorized and directed to sign on behalf of the City of Kirkland that certain Supplement No. 1 to the Washington State Department of Transportation City/County Agreement No. FAM 438 for Project No. M-2412(1) relating to federal funding for an improvement to be made on N.E. 124th Street between 116th Avenue Northeast and 132nd Avenue Northeast. A copy of said Supplement No. 1 is attached to the original of this resolution and by this reference fully incorporated herein.

The changes to the agreement are described as follows:

Termini 116th Ave. NE to 132nd Ave. NE

Description of Work

We have increased the scope of the project. Items expanded upon: curb and gutter, sidewalk, signing, storm drainage, and channelization. Items added: landscape, street lights, rockery, and railroad crossing. Consideration of the construction of these items necessitates a greater design effort and hence its cost.
