A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KIRKLAND APPROVING THE ISSUANCE OF A CONDITIONAL USE PERMIT AMENDMENT AS APPLIED FOR IN DEPARTMENT OF COMMUNITY DEVELOPMENT FILE NO. CZ-81-120 (AMENDMENT), BY JAMES WEYMOUTH TO ENLARGE THE BUILDING MOUNTED SIGN ON THE WESTERN FACADE OF THE SILVER CLOUD MOTEL BEING WITHIN A COMMUNITY BUSINESS (FREEWAY INTERCHANGE DISTRICT OVERLAY) ZONE, AND SETTING FORTH CONDITIONS TO WHICH SUCH CONDITIONAL USE PERMIT AMENDMENT SHALL BE SUBJECT.

WHEREAS, the Department of Community Development has received an application for a filed by James Weymouth, the owner of said property described in said application and located within a BC (FID Overlay) zone.

WHEREAS, the application has been submitted to the Kirkland Planning Commission who held hearing thereon at their regular meeting of June 3, 1982, and

WHEREAS, pursuant to City of Kirkland Ordinance No. 0-2473 concerning environmental policy and the State Environmental Policy Act, an environmental checklist has been submitted to the City of Kirkland, reviewed by the responsible official of the City of Kirkland and a negative declaration reached, and

WHEREAS, said environmental checklist and declaration have been available and accompanied the application through the entire review process, and

WHEREAS, the Kirkland Planning Commission after their public hearing and consideration of the recommendations of the Department of Community Development and having available to them the environmental checklist and negative declaration did adopt certain Findings, Conclusions and Recommendations and did recommend approval of the CONDITIONAL USE PERMIT AMENDMENT subject to the specific conditions set forth in said recommendations, and

WHEREAS, the City Council, in regular meeting, did consider the environmental documents received from the responsible official, together with the recommendation of the Planning Commission.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Kirkland as follows:

<u>Section 1.</u> The Findings, Conclusions and Recommendations of the Kirkland Planning Commission as signed by the Chairman thereof and filed in the Department of Community Development File No. CZ-81-120 (Amendment) are adopted by the Kirkland City Council as though fully set forth herein.

Section 2. The CONDITIONAL USE PERMIT AMENDMENT shall be issued to the applicant subject to the conditions set forth in the Recommendations hereinabove adopted by the ACity Council.

Section 3. A certified copy of this Resolution, together with the Findings, Conclusions and Recommendations therein adopted shall be attached to and become a part of the CONDITIONAL USE PERMIT AMENDMENT or evidence thereof delivered the permittee.

Section 4. Nothing in this resolution shall be construed as excusing the applicant from compliance with any federal, state or local statutes, ordinances or regulations applicable to this project, other than expressly set forth herein.

Section 5 or Failure on the part of the holder of the permit to initially meet or maintain strict compliance with the standards and conditions to which the CONDITIONAL USE PERMIT AMEND-MENT is subject shall be grounds for revocation in accordance with Ordinance Now 2183, the Kirkland Zoning Ordinance.
