

RESOLUTION NO. R 3001

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KIRKLAND APPROVING SUPPLEMENT NO. 2 TO WASHINGTON STATE DEPARTMENT OF TRANSPORTATION CITY/COUNTY AGREEMENT NO. FAM 438 FOR THE IMPROVEMENT OF N.E. 124TH STREET BETWEEN 116TH AVENUE NORTHEAST AND 132ND AVENUE NORTHEAST AND AUTHORIZING THE MAYOR TO SIGN SAME.

Whereas, the City of Kirkland heretofore by Resolution Nos. R-2770 and R-2907 authorized the Mayor to sign on behalf of the City of Kirkland, Washington State Department of Transportation City/County Agreement No. FAM 438 for Project No. M-2412(1), providing federal funding for improvements to be made on N.E. 124th Street between 116th Avenue Northeast and 132nd Avenue Northeast; and

Whereas, there are available Federal Aid Urban Secondary (FAUS) funds allocable to the City of Kirkland for construction of these improvements; and


Whereas, the City of Kirkland is expected to submit to the Washington State Department of Transportation a revised Prospectus in application for approximately \$527,000 to be used for construction of these improvements.

Now, therefore, be it resolved by the City Council of the City of Kirkland as follows:


Section 1. The Mayor is hereby authorized and directed to sign on behalf of the City of Kirkland that certain Supplement No. 2 to the Washington State Department of Transportation City/County Agreement No. FAM 438 for Project No. M-2412(1) relating to federal funding for an improvement to be made on N.E. 124th Street between 116th Avenue Northeast and 132nd Avenue Northeast. A copy of said Supplement No. 2 is attached to the original of this resolution and by this reference fully incorporated herein.

Description of Work This is to request construction funding for the above project which includes; additional traffic lanes, grading, asphalt paving, channelization, improved signalization, curbs, gutter, sidewalks, bicycle lanes, lighting, landscaping and railroad crossing improvements. No change in requested funds from previous prospectus is made,
