RESOLUTION NO. R 3016

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KIRKLAND APPROVING THE JULY, 1983 THROUGH JUNE, 1984 ONE-YEAR HOUSING AND COMMUNITY DEVELOPMENT PROGRAM AMENDED TO REFLECT THE ALLOCATION OF POPULATION AND NEEDS FUNDS AS APPROVED BY THE HOUSING AND COMMUNITY DEVELOPMENT JOINT POLICY COMMITTEE.

Whereas, the City of Kirkland jointly participates with King County and the application for funds pursuant to the Federal Housing and Community Development Act of 1974; and

Whereas, pursuant to the requirements of said act, the City heretofore by Resolution No. R-2976 approved a program plan for the year commencing July, 1983 and ending June, 1984; and

Whereas, subsequently said approved plan was submitted to the Housing and Community Development Consortium Joint Policy Committee for review, and as a result of that review, it is necessary to make certain modifications and amendments to said program plan to reflect funds actually available for allocation to the City of Kirkland; and

Whereas, the City administration has recommended certain amendments to said plan to the City council; and

Whereas, the City council has reviewed said proposal and approved said amended plan, now, therefore,

Be it resolved by the City Council of the City of Kirkland as follows:

Section 1. The City council hereby approves after consideration and review the amended one-year program plan for the period of July 1, 1983 through June 30, 1984 and finds and declares said amended plan to be consistent with and to address the problems identified in the three-year housing and community development plan adopted for the City of Kirkland by Resolution No. R-2756 pursuant to the requirements of the Federal Housing and Community Development Act of 1974.

Section 2. The one year program plan herein approved and adopted, consists of the following individual programs for which priority amount of funding and identification of funding sources, i.e., City general funds, population funds or need funds are as set forth below:
