## RESOLUTION NO. R - 3024

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KIRKLAND CANCELLING, PURSUANT TO RCW 39.56.040, CERTAIN WARRANTS OF THE CITY OF KIRKLAND NOT PRESENTED TO THE CITY FOR PAYMENT WITHIN ONE YEAR OF THEIR ISSUE.

Whereas, the Director of Administration and Finance (ex officio City Clerk) for the City of Kirkland has advised the City Council that certain warrants of the City of Kirkland remain outstanding and have not been presented for payment within one year of their issue; and

Whereas, RCW 39.56.040 requires that all warrants (other than registered or interest-bearing warrants) issued by the City of Kirkland shall be cancelled when not presented for payment within one year of their issue.

Section 1.
