

RESOLUTION NO. 3053

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KIRKLAND APPROVING THE ISSUANCE OF A PROCESS II.B PERMIT AS APPLIED FOR IN DEPARTMENT OF PLANNING AND COMMUNITY DEVELOPMENT FILE NO. IIB-83-65, BY EVERGREEN GENERAL HOSPITAL TO ALLOW A MAJOR LAND SURFACE MODIFICATION TO CONSTRUCT ADDITIONAL PARKING, ACCESS ROADS AND LANDSCAPING BEING WITHIN A PLA-12 ZONE, AND SETTING FORTH CONDITIONS TO WHICH SUCH PROCESS II.B PERMIT SHALL BE SUBJECT.

WHEREAS, the Department of Planning and Community Development has received an application for a Process II.B Permit filed by Evergreen General Hospital, the owner of said property described in said application and located within a PLA-12 zone.

WHEREAS, the application has been submitted to the Hearing Examiner who held hearing thereon at his regular meeting of September 22, 1983, and

WHEREAS, The Hearing Examiner after his public hearing and consideration of the recommendations of the Department of Planning and Community Development did adopt certain Findings, Conclusions and Recommendations and did recommend approval of the Process II.B Permit subject to the specific conditions set forth in said recommendations, and

WHEREAS, the City Council, in regular meeting, did consider the recommendation of the Hearing Examiner.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Kirkland as follows:

Section 1. The Findings, Conclusions and Recommendations of the Hearing Examiner, filed in the Department of Planning and Community Development File No. IIB-83-65, are adopted by the Kirkland City Council as though fully set forth herein.

Section 2. The Process II.B Permit shall be issued to the applicant subject to the conditions set forth in the Recommendations hereinabove adopted by the City Council.

Section 3. Nothing in this resolution shall be construed as excusing the applicant from compliance with any federal, state or local statutes, ordinances or regulations applicable to this project, other than expressly set forth herein.

Section 4. Failure on the part of the holder of the permit to initially meet or maintain strict compliance with the standards and conditions to which the Process II.B Permit is subject shall be grounds for revocation in accordance with Ordinance No. 2740, as amended, the Kirkland Zoning Ordinance.



- (d) The Office of the Director of Administration and Finance (ex officio City Clerk) for the City of Kirkland.


