

RESOLUTION R 3099

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KIRKLAND AUTHORIZING AND DIRECTING THE CITY MANAGER TO SIGN ON BEHALF OF THE CITY OF KIRKLAND, A TEMPORARY ADDENDUM TO THE EXISTING INTERLOCAL GOVERNMENTAL CONTRACT BETWEEN KIRKLAND AND KING COUNTY FIRE DISTRICT 41 FOR THE PROVISION OF FIRE SERVICES.

Whereas, King County Fire District 41 perceives a need for hiring additional fire department personnel, including four fire-fighters and one clerk as soon as possible; and

Whereas, the City of Kirkland recognizes that the addition of such personnel will provide enhanced fire and emergency services, particularly to the area of King County Fire District 41; and

Whereas, King County Fire District 41 is willing and able to underwrite the additional cost to be incurred by the City of Kirkland in hiring said additional personnel, and the City of Kirkland is willing to assume its proportionate share of such cost over a period of time; and


Whereas, both the City of Kirkland and King County Fire District 41 are in agreement, now, therefore,

Be it resolved by the City Council of the City of Kirkland as follows:


Section 1. The City Manager is hereby authorized and directed to sign on behalf of the City of Kirkland that certain addendum to the City of Kirkland King County Fire District 41 contract for services, a copy of which addendum is attached to the original of this resolution and by this reference incorporated herein.

CONTRACT TO CONTRACT FOR FIRE SERVICES
JOINT AGREEMENT BETWEEN CITY OF KIRKLAND AND
KING COUNTY FIRE DISTRICT 41

The City of Kirkland and King County Fire District 41 in consideration of the mutual promises herein set forth agree to the following addendum to the existing contract between said parties dated January 13, 1981.

1. The City of Kirkland agrees to initiate procedures (including civil service examination and appointment procedures where appropriate) for the hiring of one clerk and four firefighters by May 15, 1984.

2. King County Fire District 41 agrees to increase its annual contributions to the joint operation budget payable to the City of Kirkland, in the manner provided for in Section 3 of the base contract, by such amount as may be required to fully pay all increases in City of Kirkland Fire Department personnel costs (including but not by way of limitation, employment taxes, salaries, LLOEFF pension contributions and other employee fringe benefits and expenses) required to be paid by the City of Kirkland as a result of adding the additional personnel to the Kirkland Fire Department as provided for in Section 1 of this addendum. Provided, however, that the City of Kirkland shall pay its normal base contract share of such additional personnel costs (as provided for in Section 3 of the base contract) in accordance with the following schedule: 1984--one clerk; 1985--one clerk and one firefighter; 1986--one clerk and two firefighters; 1987--one clerk and three firefighters; 1988--one clerk and four firefighters.

3. As of the end of the 1988 budgetary or fiscal year, this addendum shall terminate and all personnel costs in relation to the additional fire department personnel subject of this addendum shall be provided for in accordance with the provisions of Section 3 of the base contract.

4. The City of Kirkland agrees that the addition of said personnel shall be utilized to provide enhanced fire and emergency services particularly to the area of King County Fire District 41.

5. The City of Kirkland agrees to use its best efforts to find additional revenue so that the schedule by which the City makes its full contribution to the joint operating budget for the additional personnel as set forth in Paragraph 2 may be accelerated. Upon prior written notice to the other party, either party may cause the provisions for payment of the additional personnel set forth in Paragraph 2 to be renegotiated at any annual joint operating budget meeting of the City and the District.

6. Should the City annex territory within the District containing property with an assessed value totaling more than \$50 million prior to December 31, 1987, then the District may rescind its obligation set forth in Paragraph 2 to make contributions to the annual joint operating budget in excess of the contributions regularly required under the existing contract between the parties dated January 13, 1981.

This addendum entered into this 14th day of May, 1984.
