

RESOLUTION NO. R 3114

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KIRKLAND, URGING THE CITIZENS OF KIRKLAND TO VOTE FAVORABLY AT THE SEPTEMBER 18, 1984 ELECTION ON KIRKLAND PROPOSITION 1 (WAVERLY SCHOOL SITE ACQUISITION BONDS) AND KIRKLAND PROPOSITION 2 (JUANITA BAY PROPERTY ACQUISITION BONDS).

Whereas, the City of Kirkland has submitted to the voters of the City of Kirkland, two propositions to authorize general obligation bonds of the City for the purpose of acquiring from Lake Washington School District 414, surplus school land commonly known as the Waverly School site which will appear on the ballot as Kirkland Proposition 1 and bonds for acquisition of the balance of the old Juanita golf course, which will appear on the ballot as Kirkland proposition 2; and

Whereas, the City Council believes that existing and anticipated development, including infilling of the lands within the Kirkland area creates an urgent need for the City to acquire when available for purchase, lands which may be utilized or reserved to meet existing and future needs of the City of Kirkland for general public and municipal purposes, facilities and uses, including but not by way of limitation, park, recreation, public assembly areas, open space, greenbelt and general park and municipal facilities; and

Whereas, the City of Kirkland has a present opportunity to acquire by purchase the lands identified herein; and

Whereas, the Kirkland City Council further believes that if said lands are not acquired at this time, then the opportunity to acquire them at a reasonable cost to the public may be forever lost; now, therefore,

Be it resolved by the City Council of the City of Kirkland as follows:

Section 1. The Kirkland City Council urges all qualified voters of the City of Kirkland to vote on September 18, 1984 for Kirkland Proposition 1, bonds for acquisition of Waverly school site.

Section 2. The Kirkland City Council hereby urges all qualified voters of the City of Kirkland to vote on September 18, 1984 for Kirkland Proposition 2, bonds for acquisition of Juanita Bay shoreline and upland property (remainder of Juanita Golf Course).

Section 3. Pursuant to the requirements of the Washington State Public Disclosure Act, consideration of this resolution by the Kirkland City Council was placed on the printed agenda for the regular council meeting of August 20, 1984 and during the course of said regular meeting of the Kirkland City Council, any members of the City Council and/or any members of the public present at said meeting, were afforded approximately equal opportunity to express views opposing adoption of the resolution and the ballot propositions herein supported by said resolution.

Passed by majority vote of the Kirkland City Council in regular, open meeting this 20th day of August, 1984.
