

RESOLUTION NO. R 3121

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KIRKLAND DECLARING AN EMERGENCY AND PROVIDING FOR THE RESUBMISSION OF PROPOSITION 1 FOR INCURRING GENERAL INDEBTEDNESS, AND ISSUING BONDS THEREFOR TO THE QUALIFIED ELECTORS OF THE CITY, AT A SPECIAL ELECTION TO BE HELD WITHIN THE CITY ON NOVEMBER 6, 1984.

Whereas, by Ordinance 2821, as amended by Ordinance 2823, the City of Kirkland did heretofore call for special election on September 18, 1984, as to two bond issue propositions known as Proposition 1, Waverly School Site Acquisition Bonds, and Proposition 2, Juanita Bay Property Acquisition Bonds; and

Whereas, in the event either or both of said propositions fail to gain the approval of the voters at said election, the City has committed itself as to Proposition 2, and reserved an option as to Proposition 1, to resubmit to the voters at the November 6, 1984 general election; and

Whereas, it is required under the statutes relating to special municipal elections that notice thereof, when held in conjunction with a general election, be given to the King County Department of Records and Elections, at least 45 days prior to the date of the general election, now, therefore,

Be it resolved by the City Council of the City of Kirkland as follows:


Section 1. The City Council finds that the needs of the City as expressed in Section 1 of Ordinance 2821 have created an emergency, and an emergency is hereby declared to exist and the King County Director of Records and Elections, as supervisor of elections, is hereby requested to concur in finding the existence of an emergency, and to call and conduct a special election to be held in the city of Kirkland on November 6, 1984, for the purpose of submitting to the qualified voters of the City for their ratification or rejection, the question of whether or not said City shall borrow the sum as set forth in proposition 1 in Section 5 of Ordinance 2821 as amended by Ordinance 2823, and issue its registered general obligation bonds therefor, for capital purposes only other than the replacement of equipment as therein set forth.

Section 2. The Kirkland Director of Administration and Finance is hereby directed to certify to the King County Director of Records and Elections, as supervisor of elections, a copy of this resolution and the propositions to be submitted at the special election to be held in the city on November 6, 1984 in the form of ballot titles as set forth in Section 5 of Ordinance 2821 as amended by Ordinance 2823.

Section 3. The Director of Administration and Finance is further authorized and directed to take such steps as may be required by the King County Department of Records and Elections to withdraw from said special election Proposition 1--Waverly School Site Acquisition Bonds, in the event said Proposition 1 is approved by the voters at the September 18 election, or upon direction of the City Council to be hereafter given to withdraw from said special election, by not later than September 28, 1984.
