RESOLUTION NO. R 3144

A RESOLUTION OF THE CITY OF KIRKLAND AND NOTICE OF HEARING FOR THE VACATION OF A portion of roadway at the intersection of Points Drive and Lake Washington Boulevard, (FILE NO. VC-85-6).

WHEREAS, a petition has been filed with the City of Kirkland signed by an owner of interest in real property representing more than two-thirds of the property abutting upon the hereinafter described portions of Points Drive.

WHEREAS, it appears that the public interest of the City of Kirkland, Washington, would be served by holding a public hearing to consider the vacation of said portion of Points Drive.

NOW, THEREFORE, be it resolved by the City Council of the City of Kirkland:

1) That a public hearing be held to consider whether the public interest and general welfare of the City of Kirkland will be served by the vacation of Points Drive, situate in Kirkland, King County, Washington, and described as follows:

That portion of Lake Washington Boulevard and SR520 Frontage Service Road (Points Drive) in Government Lot 1, Section 20, Township 25 North, Range 5 East, W.M., King County, Washington described as follows:

Commencing at the intersection of the north line of a tract of land described in instrument recorded under Recording No. 7606040639 and a line parallel with and 40.00 feet westerly of the semitangent of the centerline of Lake Washington Boulevard; thence \$00054'45"W along said parallel line 61.24 feet to intersect the arc of a curve to the right, the center of which bears N73002'08"W 256.48 feet; thence along said curve to the right through a central angle of 02°37'30", an arc distance of 11.75 feet to the True Point of Beginning; thence \$03041'00"W 27.57 feet; thence \$08048'00"W 72.97 feet to a point of curve to the right having a radius of 35.00 feet; thence along said curve to the right through a central angle of 85015'32", an arc distance of 52.08 feet to a point of curve to the left, the center of which bears \$04003'32"W 200.00 feet; thence along said curve to the left through a central angle of 15018'01", an arc distance of 53.41 feet to intersect the northwesterly margin of the SR520 Frontage Service Road (Points Drive); thence along said northwesterly margin N38042'35"E 108.41 feet; thence S51017'25"E 10.59 feet to intersect the arc of a curve to the left, the center of which bears N56046'30"W 256.48 feet; thence northeasterly along said curve to the left through a central angle of 13038'08", an arc distance of 61.04 feet to the True Point of Beginning.

Containing 4,814.06 square feet, or 0.11 acres.

2) That said public hearing will be held before the Kirkland City Council in its chambers in the Kirkland Council Building on March 18, at $8:00~\rm p.m.$
