

RESOLUTION NO. R 3164

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KIRKLAND AUTHORIZING AND DIRECTING THE CITY MANAGER TO SIGN ON BEHALF OF THE CITY OF KIRKLAND, A TEMPORARY ADDENDUM TO THE EXISTING INTERLOCAL GOVERNMENTAL CONTRACT BETWEEN KIRKLAND AND KING COUNTY FIRE DISTRICT 41 FOR THE PROVISION OF FIRE SERVICES.

Whereas, King County Fire District 41 perceives a need for hiring three additional firefighters as soon as possible; and

Whereas, the City of Kirkland recognizes that the addition of such personnel will provide enhanced fire and emergency services particularly to the area of King County Fire District 41; and

Whereas, King County Fire District 41 is willing and able to underwrite the additional cost to be incurred by the City of Kirkland in hiring three additional firefighters and the City of Kirkland is willing to assume its proportionate share of such cost over a period of time; and


Whereas, both the City of Kirkland and King County Fire District 41 are in agreement, now, therefore,

Be it resolved by the City Council of the City of Kirkland as follows:


Section 1. The City Manager is hereby authorized and directed to sign on behalf of the City of Kirkland that certain addendum to the City of Kirkland - King County Fire District 41 contract for services, a copy of which addendum is attached to the original of this resolution and by this reference incorporated herein.

1985 ADDENDUM TO CONTRACT FOR FIRE SERVICES  
JOINT AGREEMENT BETWEEN CITY OF KIRKLAND AND  
KING COUNTY FIRE DISTRICT 41  
ADDITIONAL FIREFIGHTERS

The City of Kirkland and King County Fire District 41 in consideration of the mutual promises herein set forth agree to the following addendum to the existing contract between said parties dated January 13, 1981.

1. The City of Kirkland agrees to initiate procedures (including civil service examination and appointment procedures where appropriate) for the hiring of three additional firefighters by April 22, 1985.

2. King County Fire District 41 agrees to increase its annual contributions to the joint operating budget payable to the City of Kirkland, in the manner provided for in Section 3 of the base contract, by such amount as may be required to fully pay all increases in City of Kirkland Fire Department personnel costs (including but not by way of limitation, employment taxes, salaries, LOEFF pension contributions and other employee fringe benefits and expenses), required to be paid by the City of Kirkland as a result of adding the additional firefighters to the Kirkland Fire Department as provided for in Section 1 of this addendum. Such increased contribution shall be in amounts sufficient to fully fund the personnel costs as follows:

For the balance of 1985 the personnel costs for three firefighters;

1986 the personnel costs for two firefighters;

1987 the personnel costs for one firefighter;

3. As of the end of the 1987 budgetary year or fiscal year, this addendum shall terminate and all personnel costs in relation to the additional firefighters subject to this addendum shall be provided for in accordance with the provisions of Section 3 of the base contract.

4. The City of Kirkland agrees that the addition of said personnel shall be utilized to provide enhanced fire and emergency services particularly to the area of King County Fire District 41.

5. Both parties agree that the additional fire-fighter personnel herein provided for have first priority over capital needs and for the life of this agreement, state that it is their present intention so long as reasonably possible to continue to accord such priority in the budget-making process for the years 1986, 1987 and 1988.

6. This amendment is in addition to a prior similar amendment entered into in May, 1984 respecting the addition of one clerk and four firefighters during the year 1984. Said 1984 amendment shall continue in effect according to its terms.
