A RESOLUTION OF THE CITY OF KIRKLAND AND NOTICE OF HEARING FOR THE VACATION OF RIGHTS-OF-WAY LOCATED BETWEEN 116TH AVENUE N.E. AND 118TH AVENUE N.E. AND BETWEEN N.E. 70TH STREET AND N.E. 68TH STREET (FILE NO. VC-85-70).

WHEREAS, a petition has been filed with the City of Kirkland signed by an owner of interest in real property representing more than two-thirds of the property abutting upon the hereinafter described portions of said rights-of-way.

WHEREAS, it appears that the public interest of the City of Kirkland, Washington, would be served by holding a public hearing to consider the vacation of said portion of said rights-of-way.

NOW, THEREFORE, be it resolved by the City Council of the City of Kirkland:

1) That a public hearing be held to consider whether the public interest and general welfare of the City of Kirkland will be served by the vacation of said rights-of-way, situate in Kirkland, King County, Washington, and described as follows:

That portion of the northerly 30 feet of N.E. 68th Street (formerly Oregon Street) easterly of 116th Avenue N.E. and westerly of the easterly line of Block 5, Cormode and Adsit's First Addition to Kirkland, per Volume 6 of Plats, page 44, records of King County, Washington, produced southerly. AND,

All that portion of N.E. 69th Street (formerly Washington Street) easterly of 116th Avenue N.E. and westerly of the easterly line of said above referenced Block 5 produced northerly. AND,

That portion of the westerly 30 feet of 117th Avenue N.E. together with northerly production thereof northerly of the southerly line of Block 4, said above referenced Plat, produced easterly and southerly of the centerline of N.E. 70th Street (formerly Lake Street). AND,

That portion of the northerly 20 feet of N.E. 70th Street (formerly Lake Street) easterly of the east line of the west 30 feet of said 117th Avenue N.E. produced northerly and southwesterly of the southwesterly right-of-way margin of State Aid Road No. 4 (now known as N.E. 70th Place). AND.

All that portion of N.E. 70th Street (formerly Lake Street) easterly of 116th Avenue N.E. and westerly of the easterly line of said Block 4, said above referenced Plat, produced northerly.

BE IT FURTHER RESOLVED AND NOTICE OF HEARING:

2) That said public hearing will be held before the Kirkland City Council in its chambers in the Kirkland Council Building on September 3, 1985, at 8 p.m.
