

RESOLUTION R- 3273

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KIRKLAND AUTHORIZING AND DIRECTING THE CITY MANAGER TO SIGN ON BEHALF OF THE CITY OF KIRKLAND A SERVICES AGREEMENT WITH SEATTLE KING COUNTY CONVENTION AND VISITORS BUREAU ON BEHALF OF ITS SEATTLE/KING COUNTY NEWS BUREAU.

Whereas, the City of Kirkland is authorized pursuant to RCW 35.21.700 to expend public monies and conduct promotion of resources and facilities for the purpose of attracting visitors and encouraging tourist expansion; and

Whereas, the City of Kirkland wishes to acquire professional services to perform such tourist promotion; and

Whereas, the Seattle King County Convention and Visitors Bureau on behalf of its Seattle/King County News Bureau is a Washington non-profit organization which provides such tourist promotion services and is willing so to do for the benefit of the City of Kirkland; now, therefore,

BE IT RESOLVED by the City Council of the City of Kirkland as follows:

Section 1. That certain agreement between the City of Kirkland and the Seattle King County Convention and Visitors Bureau on behalf of its Seattle/King County News Bureau, a copy of which is attached to the original of this resolution and by this reference incorporated herein, wherein said Visitors Bureau agrees to provide certain services for the purpose of attracting visitors and encouraging tourist expansion within the City of Kirkland is hereby approved.

Section 2. The City Manager is authorized and directed to sign on behalf of the City of Kirkland said contract.

SERVICES AGREEMENT

THIS AGREEMENT entered into this ____ day of _____, 1986 by and between the City of Kirkland, a municipal corporation of the State of Washington, and the Seattle King County Convention and Visitors Bureau, a non-profit corporation of the State of Washington, acting on behalf of its Seattle/King County News Bureau.

Whereas the City of Kirkland wishes to acquire professional services to attract visitors who may be going to or coming from the Vancouver, British Columbia exposition and encourage tourist expansion; and

Whereas the City of Kirkland desires to utilize the services and expertise which may be provided by the Seattle King County Convention and Visitors Bureau through its Seattle/King County News Bureau;

Now, therefore, in consideration of the mutual promises and covenants herein contained, the parties agree as follows:

1. The Seattle King County Convention and Visitors Bureau acting through its Seattle/King County News Bureau shall design and carry out publicity and other media activities designed to create awareness among Expo-bound travelers of the Seattle - King County area, including the City of Kirkland as an attractive stopover or final destination.

2. The Bureau shall maintain communication with the City of Kirkland by submitting to the City periodic reports of services being performed.

3. For the services herein contemplated, the City of Kirkland agrees to pay to the Seattle King County Convention and Visitors Bureau for the benefit of the Seattle/King County News Bureau a sum not to exceed Two Hundred Fifty (\$250.00) Dollars. This agreement shall be for a one (1) year term beginning January 1, 1986 and terminating December 31, 1986.
