

RESOLUTION NO. R 3298

A RESOLUTION OF THE CITY OF KIRKLAND AND NOTICE OF HEARING FOR THE VACATION OF N.E. 120th Street, (FILE NO. VC-86-55).

WHEREAS, a petition has been filed with the City of Kirkland signed by an owner of interest in real property representing more than two-thirds of the property abutting upon the hereinafter described portions of N.E. 120th Street.

WHEREAS, it appears that the public interest of the City of Kirkland, Washington, would be served by holding a public hearing to consider the vacation of said portion of N.E. 120th Street.

NOW, THEREFORE, be it resolved by the City Council of the City of Kirkland:

1) That a public hearing be held to consider whether the public interest and general welfare of the City of Kirkland will be served by the vacation of N.E. 120th Street, situate in Kirkland, King County, Washington, and described as follows:

The South 30.00 feet, of the Southeast quarter, of the Northeast quarter, of the Southeast quarter, of Section 29, Township 26 North, Range 5 East, W.M., King County, Washington;  
TOGETHER WITH the North 30.00 feet of the Northeast quarter, of the Southeast quarter, of the Southeast quarter, of said Section 29.

AND TOGETHER WITH that portion of the South 30.00 feet, of the East half, of the Southwest quarter, of the Northeast quarter, of the Southeast quarter and that portion of the North 30.00 feet of the East half, of the Northwest quarter, of the Southeast quarter, of the Southeast quarter, of said Section 29, lying East of a line described as follows: Commencing at the intersection of the South line of the North 30.00 feet of said East half, of the Northwest quarter, of the Southeast quarter, of the Southeast quarter, with the East line thereof; thence N 89°01'57"W along said South line of the North 30.00 feet, a distance of 149.12 feet to the TRUE POINT OF BEGINNING of said described line; thence N 0°58'03"E 60.00 feet to the North line of the South 30.00 feet of said East half, of the Southwest quarter, of the Northeast quarter, of the Southeast quarter and the terminus of said described line.

BE IT FURTHER RESOLVED AND NOTICE OF HEARING:

2) That said public hearing will be held before the Kirkland City Council in its chambers in the Kirkland Council Building on August 4, 1986, at 8:00 p.m..
