RESOLUTION NO. R-3316

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KIRKLAND APPROVING THE JULY 1987 THROUGH JUNE 1988 ONE-YEAR HOUSING AND COMMUNITY DEVELOPMENT PROGRAM ESTABLISHING PRIORITIES AS TO AMOUNT OF FUNDS TO BE ALLOCATED EACH INDIVIDUAL PROGRAM AND THE SOURCE OF SAID FUNDS AND DECLARING SAID ONE-YEAR PROGRAM TO BE CONSISTENT WITH THE 1987 FUNDING GUIDELINES HERETOFORE APPROVED ON JULY 7, 1986 BY RESOLUTION NO. R-3294.

WHEREAS, pursuant to said act, the City is required to develop and approve a program plan for the year commencing July, 1987 and ending June, 1988, which plan shall be consistent with and address the needs identified in the funding guidelines heretofore approved by the City Council on July 7, 1986 by Resolution No. R-3294; and

WHEREAS, the City administration has developed and recommended such a one-year program plan to the City Council; and

WHEREAS, the City Council has received said one-year program plan, held a public hearing thereon October 6, 1986, and approved said plan, now, therefore;

BE IT RESOLVED by the City Council of the City of Kirkland as follows:

Section 1. The City Council hereby approves, after consideration and review, the one-year program plan for the period of July 1, 1987 through June 30, 1988, and finds and declares said plan to be consistent with and to address the problems identified in the 1987 funding guidelines adopted for the City of Kirkland by Resolution No. 3294, pursuant to the requirements of the Federal Housing and Community Development Act of 1974.

Section 2. The one-year program herein approved and adopted consists of the following individual programs for which priority amount of funding and identification of funding source, i.e., City General funds, Population funds are as set forth below:
