## RESOLUTION R 3324

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KIRKLAND AUTHORIZING THE MAYOR AND THE DIRECTOR OF ADMINISTRATION AND FINANCE TO SIGN ON BEHALF OF THE CITY OF KIRKLAND A REQUEST FOR PARTIAL RECONVEYANCE AS TO THAT PORTION OF THE OLD CITY HALL SITE BEING ACQUIRED BY THE MUNICIPALITY OF METROPOLITAN SEATTLE.

Whereas, the City of Kirkland is the Beneficiary under that certain Deed of Trust hereinafter described as security for payment of the sale price for the old City Hall site; and

Whereas, the municipality of Metropolitan Seattle is acquiring a portion of said City Hall site for its purposes and it is necessary therefor to provide clear title to the municipality of Metropolitan Seattle that said portion so acquired be released from Deed of Trust; now, therefore,

Be it resolved by the City Council of the City of Kirkland as follows:

Section 1. The Mayor and Director of Administration and Finance for the City of Kirkland are hereby authorized to sign on behalf of the City of Kirkland a request for partial reconveyance as to that portion of the old City Hall site as specifically described in Exhibit "A" hereto which by this reference is incorporated herein; provided, however, that the monies to be paid by Metro for the acquisition of said real property shall be paid to the City of Kirkland and applied against the presently past due payments of principal and interest on that certain purchase money note held by the City of Kirkland as a part of the sale price of the old City Hall site and secured by said Deed of Trust.


## REQUEST FOR PARTIAL RECONVEYANCE
