

RESOLUTION R- 3333

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KIRKLAND AUTHORIZING THE MAYOR AND THE DIRECTOR OF ADMINISTRATION AND FINANCE TO SIGN ON BEHALF OF THE CITY OF KIRKLAND A QUIT CLAIM DEED TO FIRST CITY INVESTMENTS, INC. AS TO A PORTION OF POINTS DRIVE HERETOFORE VACATED BY ORDINANCE 2971.

Whereas, the City of Kirkland heretofore vacated by Ordinance 2971 portions of Points Drive, all as described in said Ordinance; and

Whereas, First City Investments, Inc., the abutting property owner, at the time of said right-of-way vacation, conveyed to the City of Kirkland alternative right-of-way; and

Whereas, it now appears that the hereinafter described portion of Points Drive right-of-way as vacated by Ordinance 2971 is also subject to a fee interest in favor of the City of Kirkland; and

Whereas, it was the intention of the City of Kirkland for all of said property vacated by Ordinance 2971 to attach to the property abutting thereto, which property is owned by First City Investments, Inc.; now, therefore,

Be it resolved by the City Council of the City of Kirkland as follows:

Section 1. The Mayor and the Director of Administration and Finance for the City of Kirkland are hereby authorized and directed to sign on behalf of the City of Kirkland that certain Quit Claim Deed between the City of Kirkland, as Grantor, and First City Investment, Inc., as Grantee, as to the real property described in attachment "A" to this Resolution and by this reference incorporated herein.
