## RESOLUTION R-3355

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KIRKLAND AMENDING THE 1987 - 1988 HOUSING AND COMMUNITY DEVELOPMENT PROGRAM AND AMENDING SECTION 2 OF RESOLUTION R3316. ADOPTED OCTOBER 20, 1986.

Whereas, the City Council, on October 20, 1986 adopted Resolution R-3316 titled:

" A Resolution of the City Council of the City of Kirkland approving the July, 1987 through June, 1988 one-year housing and community development program establishing priorities as to the amount of funds to be allocated each individual program and the source of said funds and declaring said one-year program to be consistent with the 1987 funding guidelines heretofore approved on July 7, 1986 by Resolution R-3294";

and

Whereas, King County, as Housing and Community Development Block Grant Administrator, has determined that the 18th Avenue sidewalk (Market - 4th Street) does not meet the Block Grant low/moderate income household criteria; and

Whereas, a similar sidewalk, curb and gutter program on 120th Avenue Northeast from Northeast 80th to Northeast 83rd Street does meet such criteria; now, therefore,

Be it resolved by the City Council of the City of Kirkland as follows:

Section 1. Section 2 of Resolution R-3316 be and it hereby is amended to read as follows:

Section 2. The one-year program herein approved and adopted consists of the following individual programs for which priority amount of funding and identification of funding source, i.e., City General funds, Population funds are as set forth below:
