

RESOLUTION NO. R-3365

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KIRKLAND AND NOTICE OF HEARING FOR THE VACATION OF AN UNIMPROVED PORTION OF ALEXANDER AVENUE ABUTTING LOT 96, BLOCK 59, BURKE AND FARRAR'S ADDITION, DIVISION NO. 16.

WHEREAS, a portion of Alexander Avenue fronting on Lot 96, Block 59, Burke and Farrar's Kirkland Addition, Division No. 16 was vacated by Ordinance 2045 adopted April 7, 1969; and

WHEREAS, the owners of said Lot 96 have requested vacation of an additional portion of the Alexander Avenue right-of-way; and

WHEREAS, it appears that the public interest of the City of Kirkland would be served by holding a public hearing to consider the vacation of the portion of Alexander Avenue right-of-way hereinafter described; and

WHEREAS, the City Council by Resolution R-3359 established a hearing date of April 6, 1987; and

WHEREAS, pursuant to K.M.C. 19.16.110.(b), April 6, 1987 gives insufficient time for hearing notice;

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Kirkland as follows:

1. That a public hearing be held to consider whether the public interest and general welfare of the City of Kirkland will be served by the vacation of that portion of the Alexander Avenue right-of-way not presently improved for street purposes and specifically described as follows:

That portion of Alexander Avenue lying westerly of the following described line: beginning at the southeast corner of Lot 97, Block 59, Burke and Farrar's Kirkland Addition, Division 16 as recorded in volume 20 of Plats, page 58; thence north 09°01'01" east 75.46 feet; thence north 20°12'33" east 87.74 feet; thence north 13°59'08" east 47.13 feet to a point on the margin of Alexander Avenue as per plat of Burke and Farrar's Kirkland Addition, Division 16 as recorded in volume 20 of Plats, page 58.

Be it further resolved and notice of hearing:

2. That a public hearing be held before the Kirkland City Council in its chambers in the Kirkland City Hall, 123 Fifth Avenue, Kirkland, Washington on April 20 rather than April 6, 1987 at 7:30 p.m.
