

RESOLUTION NO. R-3383

A RESOLUTION OF THE CITY OF KIRKLAND AND NOTICE OF HEARING FOR THE VACATION OF a portion of N.E. 112th Street, (FILE NO. VC-87-44).

WHEREAS, a petition has been filed with the City of Kirkland signed by an owner of interest in real property representing more than two-thirds of the property abutting upon the hereinafter described portions of N.E. 112th Street.

WHEREAS, it appears that the public interest of the City of Kirkland, Washington, would be served by holding a public hearing to consider the vacation of said portion of N.E. 112th Street.

NOW, THEREFORE, be it resolved by the City Council of the City of Kirkland:

1) That a public hearing be held to consider whether the public interest and general welfare of the City of Kirkland will be served by the vacation of N.E. 112th Street, situate in Kirkland, King County, Washington, and described as follows:

N.E. 112th Street being that portion of the north half of said N.E. 112th Street lying between the easterly line of 120th Avenue N.E. and the westerly line of S.R. 405 particularly:

That portion of the N.E. 1/4 of the N.W. 1/4 of Sec. 33T.26N.R.5E.W.M. beginning at the S.W. corner of said subdivision; thence S89°10'41"E 148.58'; thence N13°25'37"E 30.74'; thence N89°10'41"W 155.20'; thence S0°59'24"W 30.00' to the true point of beginning.

Said parcel contains 4,557 sq. ft. vacation description of that portion of N.E. 112th Street being that portion of the S 1/2 of said N.E. 112th Street lying between the easterly line of 120th Avenue N.E. and the westerly line of S.R. 405. Particularly:

That portion of the S.E. 1/4 of the N.W. 1/4 of Sec. 33T.26N.R.5E.W.M. beginning at the N.W. corner of said subdivision; thence S89°10'41"E 30.00' to the true point of beginning; thence S89°10'41"E 148.58'; thence S13°25'37"W 30.74'; thence N89°10'41"W 141.96'; thence N0°59'24"E 30.00 to the true point of beginning.

Said parcel contains 4,358 sq. ft.

BE IT FURTHER RESOLVED AND NOTICE OF HEARING:

2) That said public hearing will be held before the Kirkland City Council in its chambers in the Kirkland Council Building on July 6, 1987, at 7:30 p.m..
