

RESOLUTION NO. R 3407

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KIRKLAND AFFIRMING THE INTENT OF THE CITY OF KIRKLAND TO HOLD ELECTIONS ON THE QUESTION OF ANNEXATION OF LOWER JUANITA, NORTH ROSE HILL, AND SOUTH ROSE HILL, UNINCORPORATED AREAS CONTIGUOUS TO THE CITY OF KIRKLAND. (File CC-87-86)

WHEREAS, on August 18, 1986, the City Council adopted Resolution R-3309, declaring the City's intent to establish 1987 as a target date for annexation elections in Lower Juanita, North Rose Hill, and South Rose Hill; and

WHEREAS, on October 20, 1986, the City Council adopted Resolution R-3320, establishing three ad hoc advisory citizen committees to study the potential annexation areas of Lower Juanita, North Rose Hill, and South Rose Hill; and

WHEREAS, each of these annexation advisory committees has met and extensively discussed land use, service, and infrastructure issues relating to their potential annexation area; and

WHEREAS, each of the annexation advisory committees has reported and made recommendations to the Kirkland City Council; and

WHEREAS, the City Council has had the opportunity to review and act upon the recommendations from each of the citizen advisory committees; and

WHEREAS, the City Council adopted Resolutions R-3349, R-3350, and R-3357 to initiate the annexation by election process for each area; and

WHEREAS, the Boundary Review Board for King County, on July 13, 1987, held a public hearing on the question of whether an election should be held on the question of annexation within the Lower Juanita, North Rose Hill, and South Rose Hill areas; and

WHEREAS, on July 30, 1987, the Boundary Review Board for King County did pass a resolution approving annexation elections in the Lower Juanita, North Rose Hill, and South Rose Hill areas.

WHEREAS, on August 17, 1987, the Kirkland City Council held a public hearing for current City residents to comment on the proposed annexations.

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Kirkland as follows:

Section 1. The intent of the City of Kirkland to hold elections for the annexations of Lower Juanita, North Rose Hill, and South Rose Hill is hereby affirmed.

Section 2. The City Council recommends the election date be November 3, 1987. The election shall be structured so that voters in each potential annexation area shall determine whether their area should annex independent of the decision of the other two annexation areas.

Section 3. Questions on the ballot shall be:

- 1) Whether to annex to the City of Kirkland;
- 2) Whether to accept the bonded indebtedness of the City of Kirkland.

Resolutions R-3349, R-3350 and R-3357 contain the exact ballot wording for these questions.
