

RESOLUTION NO. R-3467

A RESOLUTION OF THE CITY OF KIRKLAND AND NOTICE OF HEARING FOR THE VACATION OF A PORTION OF THE 2ND AVENUE RIGHT-OF-WAY, BETWEEN THE VACATED 5TH AND 6TH STREET RIGHT-OF-WAY, (FILE NO. (IV-88-82)).

WHEREAS, a petition has been filed with the City of Kirkland signed by an owner of interest in real property representing more than two-thirds of the property abutting upon the hereinafter described portions of the 2nd Avenue right-of-way.

WHEREAS, it appears that the public interest of the City of Kirkland, Washington, would be served by holding a public hearing to consider the vacation of said portion of the 2nd Avenue right-of-way.

NOW, THEREFORE, be it resolved by the City Council of the City of Kirkland:

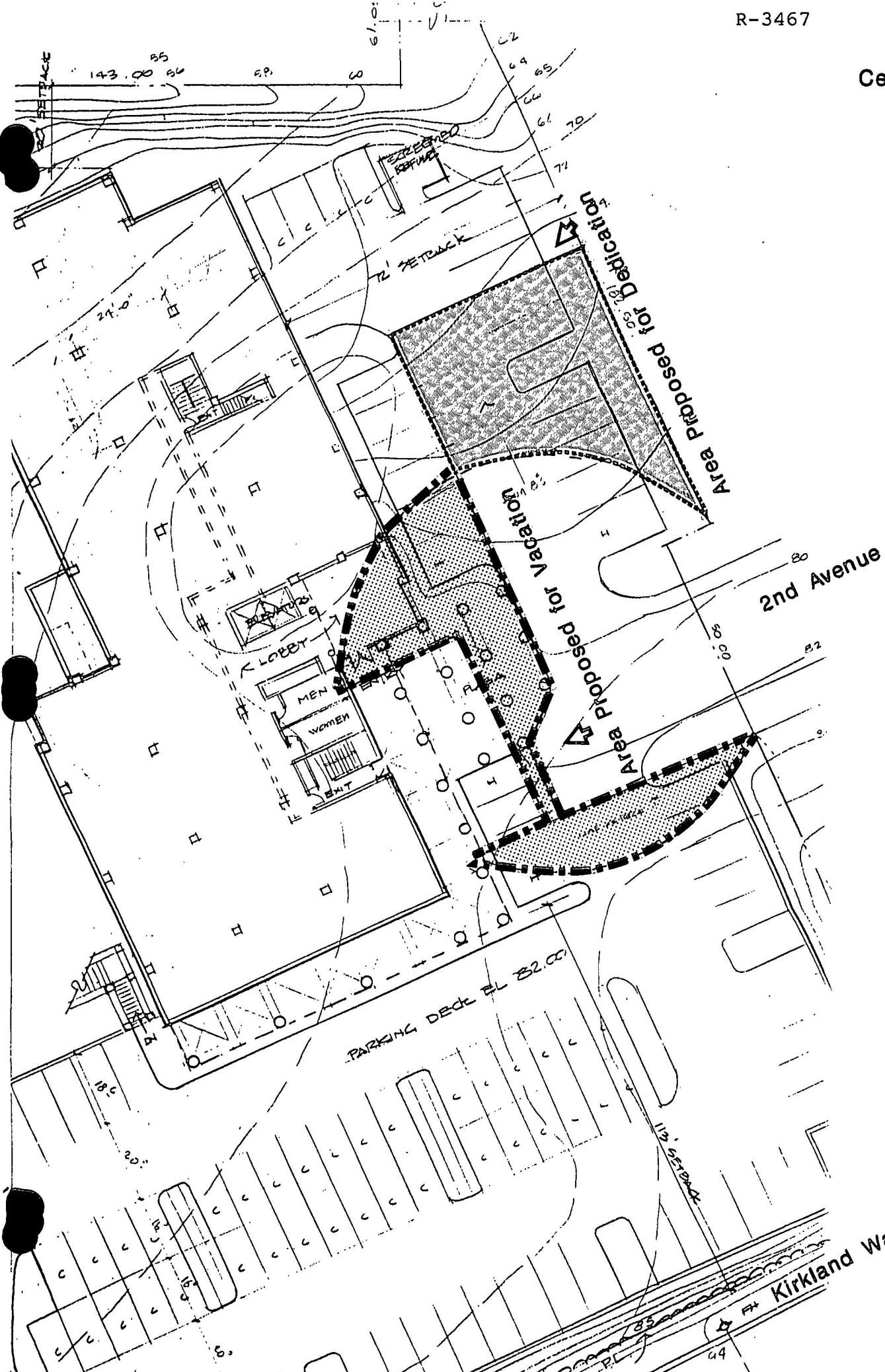

ATTACHMENT A

A PORTION OF 2ND AVENUE (ALSO KNOWN AS N.E. 83RD STREET) DESCRIBED AS FOLLOWS:

BOUNDED ON THE WEST BY THE NORTHERLY PROLONGATION OF THE WESTERLY RIGHT-OF-WAY OF 5TH STREET (ALSO KNOWN AS 107TH AVENUE N.E.); BOUNDED ON THE EAST BY A LINE WHICH IS RADIAL TO THE CENTERLINE OF 2ND AVENUE AND WHICH LINE 15.00 FEET WESTERLY, AS MEASURED ALONG THE NORTHERLY RIGHT-OF-WAY OF 2ND AVENUE, FROM THE SOUTHEASTERLY CORNER OF LOT 23, BLOCK 174, BURKE AND FARRAR'S KIRKLAND ADDITION, ALL IN THE SOUTHEAST QUARTER OF THE SOUTHWEST QUARTER OF SECTION-5, TOWNSHIP 25 NORTH, RANGE 5 EAST, W.M., IN KING COUNTY, WASHINGTON.
