RESOLUTION NO. R- 3469

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KIRKLAND APPROVING THE BAYVIEW PLACE SHORT PLAT AS APPLIED FOR BY BRAD KELLERAN BEING DEPARTMENT OF PLANNING AND COMMUNITY DEVELOPMENT FILE NO. IIB-SS-88-78 AND SETTING FORTH CONDITIONS TO WHICH SUCH PLAT SHALL BE SUBJECT.

WHEREAS, the Department of Planning and Community Development has received application for a short plat of property within an RS 8.5 zone and said application having been made by Brad Kelleran the owner of the real property described in said application; and

WHEREAS, pursuant to the State Environmental Policy Act, RCW 43.21C and the Administrative Guideline and local ordinance adopted to implement it, an environmental checklist has been submitted to the City of Kirkland, reviewed by the responsible official of the City of Kirkland, and a determination of non-significance issued; and

WHEREAS, said environmental checklist and determination have been available and accompanied the application throughout the entire review process; and

WHEREAS, the proposal for a short plat has been submitted to the Kirkland Hearing Examiner who held public hearing thereon July 14, 1988; and

WHEREAS, the Kirkland Hearing Examiner, after public hearing and consideration of all testimony and evidence, the recommendations of the Department of Planning and Community Development, did adopt certain Findings, Conclusions and Recommendations and did recommend approval of the short plat subject to the specific conditions set forth in said recommendation, and

WHEREAS, the City Council, in regular meeting, did consider the environmental documents received from the responsible official, together with the recommendation of the Hearing Examiner.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Kirkland as follows:

<u>Section 1</u>. The Findings, Conclusions and Recommendations of the Kirkland Hearing Examiner as signed by him and filed in Department of Planning and Community Development File No. IIB-SS-88-78 are hereby adopted by the Kirkland City Council as though fully set forth herein.

<u>Section 2</u>. The short plat of Bayview Place is hereby given approval subject to the conditions set forth in the recommendations here-in-above adopted by the City Council.

<u>Section 3</u>. Nothing in this Resolution shall be construed as excusing the applicant from compliance with all federal, state, or local statutes, ordinances, or regulations applicable to this subdivision other than as expressly set forth herein.

<u>Section 4</u>. A certified copy of this Resolution, along with the Findings, Conclusions and Recommendations here-in-above adopted, shall be attached to and become a part of the evidence of the short plat approval to the applicant. Section 5. Certified or conformed copies of this Resolution shall be delivered to the following:
