

RESOLUTION NO. R-3524

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KIRKLAND APPROVING THE PLANNING WORK PROGRAM FOR THE KIRKLAND PLANNING COMMISSION.

WHEREAS, the Kirkland City Council and Planning Commission met on April 11, 1989 to discuss the Planning Commission's work program for the following year; and

WHEREAS, the City Council seeks to balance the competing demands for the Planning Commission's time in a way which maximizes the public interest; and

Section 1. The planning work program, as set forth in Exhibit A to this resolution, is hereby adopted as the work program of the Planning Commission.
