

RESOLUTION NO. R- 3541

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KIRKLAND URGING THE CITIZENS OF KIRKLAND TO VOTE FAVORABLY AT THE SEPTEMBER 19, 1989 ELECTION ON KIRKLAND PROPOSITION NO. 1 PARK BONDS - \$5,760,000.

WHEREAS, the City of Kirkland has submitted to the voters of the City of Kirkland a proposition to authorize general obligation bonds of the City in the amount of \$5,760,000 for the following purposes:

Acquisition and development of lands within the South Juanita area of the City along N.E. 124th Street and commonly known as the Eastside Foursquare Church property for conversion for park and other recreational uses;

Development and redevelopment, including capital improvements to the City's existing Everest and Crestwoods community parks;

Development for park purposes, including limited capital improvements to the City's existing Juanita Bay Park, all in accordance with its approved Master Plan;

Acquisition and development for neighborhood park purposes, including capital improvements, of surplus Lake Washington School District No. 414 school lands, commonly known as a portion of "Lake Washington School District Administrative Site";

Development, including master planning and capital improvements, to lands within North Rose Hill adjacent to 124th Avenue N.E. for a North Rose Hill neighborhood park (excluding any land acquisition cost);

Acquisition and development of land within the South Rose Hill/Bridle Trails area of the City for a neighborhood park; and

Acquisition, as the opportunity may arise, of lands for open space neighborhood parks and Lake Washington waterfront for general park and recreational purposes; and

WHEREAS, the City of Kirkland is in urgent need of acquiring, developing, redeveloping and improving land for open space and park facilities, including improving existing parks as above described, and the City does not have sufficient funds available for that purpose to meet the estimated cost thereof, now, therefore,

BE IT RESOLVED by the City Council of the City of Kirkland as follows:

Section 1: The Kirkland City Council urges all qualified voters of the City of Kirkland to vote on September 19, 1989, for Kirkland Proposition No. 1, Kirkland Park Bonds - \$5,760,000.

Section 2: Pursuant to the requirements of the Washington State Public Disclosure Act, consideration of this resolution by the Kirkland City Council was placed on the printed agenda for the regular Council meeting of August 15, 1989, and during the course of said regular meeting of the Kirkland City Council, any members of the City Council and/or any members of the public present at said meeting were afforded approximately equal opportunity to express view opposing adoption of the resolution and the ballot proposition herein supported by said resolution.

Passed by majority vote of the Kirkland City Council in regular, open meeting this 15th day of August, 1989.
