

RESOLUTION NO. R-3640

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KIRKLAND AUTHORIZING THE CITY MANAGER TO SIGN ON BEHALF OF THE CITY OF KIRKLAND, A GRANT OF QUITCLAIM DEED TO TOTEM SKYLINES ASSOCIATES II LIMITED PARTNERSHIP, A WASHINGTON LIMITED PARTNERSHIP

WHEREAS, Totem Skylines Associates II Limited Partnership has requested a quitclaim deed from the City of Kirkland to relinquish an easement together with the right to grant easements along, over, and under a portion of the vacated NE 120th Street for the installation, construction, repair, and maintenance of public utilities and services in connection with vacation of the NE 120th Street right-of-way in the Kirkland 405 Corporate Center Business Park, and

WHEREAS, the City Council did adopt Ordinance No 3004 on February 2, 1987, vacating the NE 120th Street right-of-way, except for the retention of said easement, and

WHEREAS, Building E (Lot 5) in the Kirkland 405 Corporate Center Business Park is constructed over a portion of said easement, and

WHEREAS, the Planning Department has recommended the granting of such quitclaim deed, and

WHEREAS, the City Council has reviewed and considered the quitclaim deed,


NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Kirkland as follows

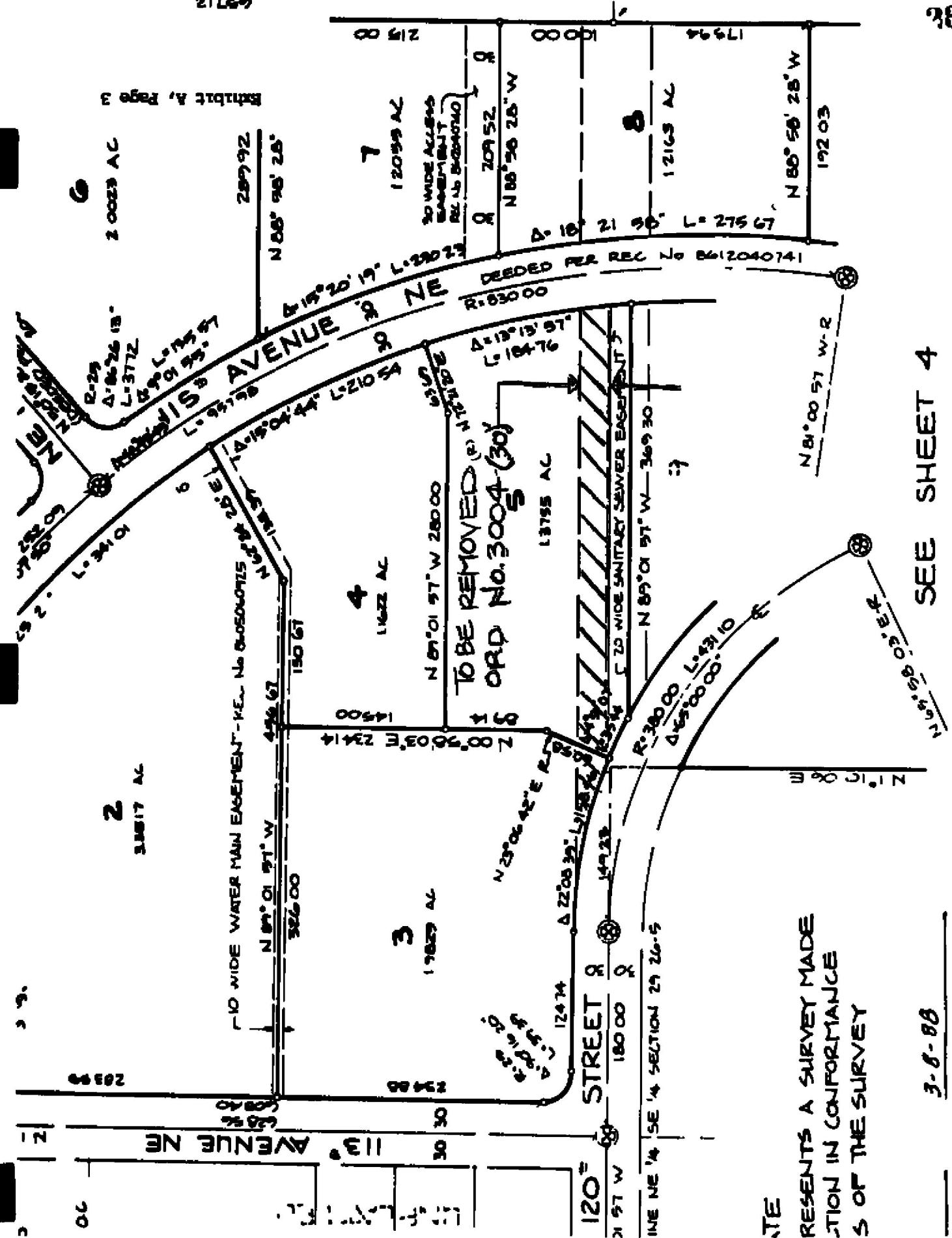
AREA OF KIRKLAND ORDINANCE No. 3004 TO BE REMOVED FROM
LOTS 3 AND 5
TOTEM SKYLINE BUSINESS PARK

That portion of Lots 3 and 5, TOTEM SKYLINE BUSINESS PARK, according to the plat thereof filed in Volume 141 of Plats on pages 1 through 6 inclusive, records of King County, Washington described as follows, Commencing at the Southeast corner of said Lot 5, thence northerly along a curve to the left having a radius of 800.00 feet the radial point bearing S 85°35'17" W through a central angle of 1°04'48" an arc distance of 16.08 feet to the TRUE POINT OF BEGINNING, thence N 89°01'57" W parallel with the south line thereof 400.54 feet to a point on the east margin of NE 120th Street, said point lying on the arc of a curve to the left the radial point bearing S 23°01'19" W, thence along said curve to the left having a radius of 410.00 feet through a central angle of 22°03'16" an arc distance of 157.82 feet, thence S 89°01'57" E 550.52 feet to a point on west margin of 115th Avenue NE, said point lying on the arc of a curve to the right the radial point bearing S 82°20'26" W, thence along said curve to the right having a radius of 800.00 feet through a central angle of 2°10'03" an arc distance of 30.26 feet to the TRUE POINT OF BEGINNING.
