A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KIRKLAND APPROVING THE JANUARY 1, 1992 THROUGH DECEMBER 31, 1992 HOUSING AND COMMUNITY DEVELOPMENT PROGRAM ESTABLISHING PRIORITIES AS TO AMOUNT OF FUNDS TO BE ALLOCATED EACH INDIVIDUAL PROGRAM AND THE SOURCE OF SAID FUNDS AND DECLARING SAID PROGRAM TO BE CONSISTENT WITH THE 1991 FUNDING GUIDELINES HERETOFORE APPROVED ON APRIL 2, 1991, BY RESOLUTION NO R-3661

WHEREAS, pursuant to the Federal Housing and Community Development Act of 1974, the City is required to develop and approve a program plan for the period commencing January 1, 1992, and ending December 31, 1992, which plan shall be consistent with and address the needs identified in the funding guidelines heretofore approved by the City Council by Resolution No R-3661, and

WHEREAS, the City administration has developed and recommended such a program plan to the City Council, and

WHEREAS, the City Council has received said program plan, held a public hearing thereon September 3, 1991, and approved said plan, now, therefore,

BE IT RESOLVED by the City Council of the City of Kirkland as follows

Section 1. The City Council hereby approves after consideration and review, the program plan for the period of January 1, 1992, through December 31, 1992, and finds and declares said plan to be consistent with and to address the problems identified in the 1991 funding guidelines adopted for the City of Kirkland by Resolution No 3661, pursuant to the requirements of the Federal Housing and Community Development Act of 1974

<u>Section 2.</u> The program herein approved and adopted consists of the following individual programs for which priority amount of Housing and Community Development funds are as set forth below (see attached program breakdown)

Section 3. Gramm-Rudman Contingency

In the event the Gramm-Rudman Act operates to mandate reductions on the federal level of amounts of Community Development Block Grant funding, and as a result thereof, the Block Grant funding allocation to the City of Kirkland is reduced then in that event, the reduction shall be applied on a pro rata basis to the 1992 Housing and Community Development, Public Service and Capital Improvement Projects approved herein, provided that such reduction, as may be required for Capital Improvements projects, shall be borne entirely by the NE 100th Street Sidewalk and Handicapped Playground projects equally and such reduction as may be required for Public Service projects shall be borne entirely be the Employment **Opportunities Center project**

<u>Section 4.</u> The City Manager is hereby authorized and directed to sign on behalf of the City of Kirkland any and all documents, including agreements which may be required, in order to submit said plan and carry out the programs contained in said plan
