A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KIRKLAND AUTHORIZING AND DIRECTING THE CITY MANAGER TO SIGN ON BEHALF OF THE CITY OF KIRKLAND THAT CERTAIN QUIT CLAIM DEED CLARIFYING THE BOUNDARY OF MARK TWAIN PARK.

Whereas, Donald Wicklund has requested that the City of Kirkland acknowledge his acquisition of title to a strip of land which adjoins Mark Twain Park before the Park property was acquired by King County; and

Whereas, the City of Kirkland and Donald Wicklund both wish to clarify the property line between Mark Twain Park and Donald Wicklund's property; and

Whereas, the attached Quit Claim Deed reflects the mutual agreement of the parties regarding the correct boundary;

Now, Therefore, be it resolved by the City Council of the City of Kirkland as follows:

Section 1. The City Manager is hereby authorized and directed to sign that certain Quit Claim Deed which is attached hereto on behalf of the City of Kirkland.

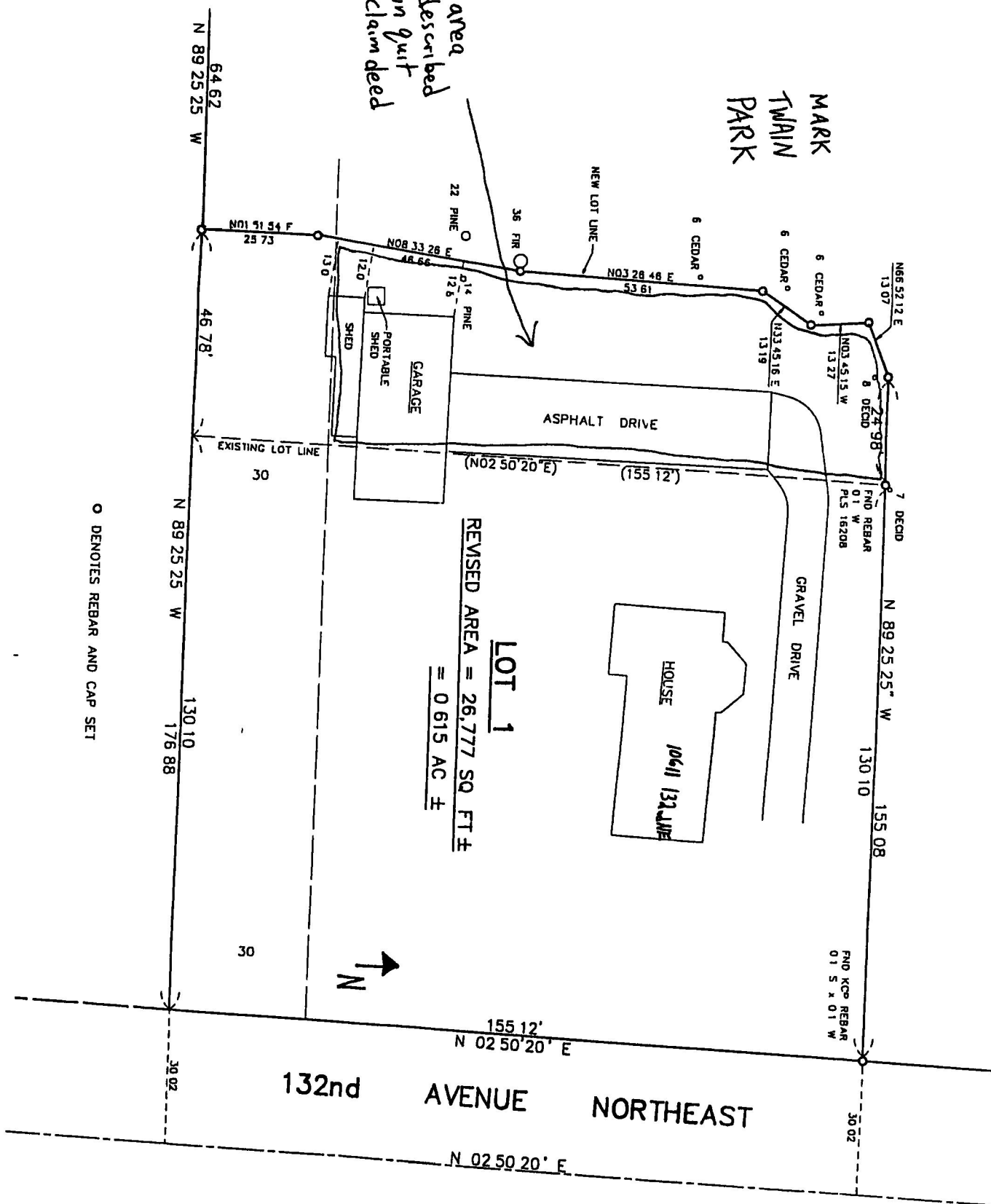
