RESOLUTION NO. R-3794

A RESOLUTION PERTAINING TO THE PLANNING WORK PROGRAM OF THE CITY OF KIRKLAND.

WHEREAS, the Kirkland City Council, the Growth Management Commission, and the Kirkland Planning Commission met in February of 1993 to discuss anticipated tasks and set planning priorities for the upcoming year; and

WHEREAS, at that meeting, the City Council, Growth Management Commission, and Planning Commission established the rank order priority and several target deadlines for the tasks shown on the draft Planning Work Program, and

WHEREAS, the City Council and Planning Commission determined that the Hearing Examiner's workload could better accommodate the site-specific zoning permit hearings which would normally be addressed by the Planning Commission; and

WHEREAS, it would be beneficial to all parties to have the agreed-upon Planning Work Program and change to the site-specific zoning permit hearing body formally adopted by the City Council,

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Kirkland as follows

Section 1 The Planning Work Program for the City of Kirkland shall be established as shown on Exhibit A to this resolution

Section 2 This adopted Planning Work Program shall be used by the City staff, Planning Commission, Growth Management Commission, and Hearing Examiner in scheduling work tasks, meeting and hearing calendars

Section 3 For the period of this work program, all recommendations to the City Council on site-specific zoning permits shall come from the Hearing Examiner rather than the Planning Commission

Section 4 This Planning Work Program shall be subject to review and amendment at the fall 1993 joint meeting of the City Council, Growth Management Commission, and Planning Commission

Section 5 A copy of this resolution shall be distributed to the Planning Commission, Growth Management Commission, Hearing Examiner, and Houghton Community Council
