Whereas, Waste Management of North America, Inc. has in a corporate reorganization consolidated its Washington State legal entities resulting in the merger of Waste Management - Sno-King, Inc. to Waste Management - Sno-King, a division of Washington Waste Hauling & Recycling, Inc.

Whereas, said merge amounts to a technical legal assignment of the contract existing between Waste Management - Sno-King, Inc. and the City of Kirkland for solid waste and recycling collection,

Now, Therefore, be it resolved by the City Council of the City of Kirkland as follows

Section 1 The City Council of the City of Kirkland hereby accepts and approves assignment of the City's solid waste and recycling collection contract with Waste Management - Sno-King, Inc from Waste Management - Sno-King, Inc to Waste Management - Sno-King, a division of Washington Waste Hauling & Recycling, Inc subject to the following

a Waste Management - Sno-King, a division of Washington Waste Hauling & Recycling, Inc files with the City a written assignment and acceptance of all duties, liabilities and obligations arising out of said contract during the entire term of said contract, including all duties to perform each and every provision of said contract with said assignment and acceptance to be signed by the appropriate corporate officials of both the assignor and the assignee

b Waste Management - Sno-King, a division of Washington Waste Hauling & Recycling, Inc shall at its expense, obtain and file with the City within thirty days of the adoption of this Resolution, a new or amended performance bond in its name as principal, together with certificates of insurance issued by the appropriate insurance carriers meeting the insurance requirements set forth in the solid waste collection contract

<u>Section 2</u> A copy of this resolution, together with a copy of the properly executed assignment and acceptance of contract, shall be certified by the City Clerk for the City of Kirkland and attached to the solid waste collection contract as an amendment thereto
