A RESOLUTION OF THE CITY OF KIRKLAND AND NOTICE OF HEARING FOR THE VACATION OF THE WEST ONE HALF OF SECOND STREET, (FILE NO. VC-94-125).

WHEREAS, a petition has been filed with the City of Kirkland signed by the owners of real property representing more than two-thirds of the property abutting upon the hereinafter described portions of Second Street.

Beginning at the Northeast corner of said Block 214;

Thence South 1*24'00" East along the east line of said Block 214 and the west margin of 2nd St. 114.56 feet, to the northerly margin of Central Way (S.S.H. No. 2D);

Thence North 71°50'47" East along said northerly margin of Central Way 31.33 feet, to the centerline of 2nd St.;

Thence North 1°24'00" West along the centerline of 2nd St. 128.90 feet to the midpoint of a line from the northeast corner of aforementioned Block 214, to the northwest corner of Block 93, Kirkland Terrace, according to the Plat recorded in Volume 24 of Plats, Page 42, records of King County, Washington; Thence South 50°41'13" West 38.03 feet to the True Point of Beginning.
