

RESOLUTION R- 3951

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KIRKLAND RELINQUISHING ANY INTEREST IN UNOPENED STREETS AS REQUESTED IN FILE NO. NU-94-132.

Whereas, the City has received a request to permanently abandon any rights to the land originally dedicated in 1891 as right-of-way abutting a portion of the plat of Supplementary Plat to Kirkland; and

Whereas, the Laws of 1889, Chapter 19, Section 32, provides that any county road which remains unopened for five years after authority is granted for opening the same is vacated; and

Whereas, the area which is the subject of this request was annexed to the City in 1967, with the relevant right-of-way having been unopened; and

Whereas, in this context it is in the public interest to resolve this matter by agreement,

Now, therefore, be it resolved by the City Council of the City of Kirkland as follows:

Section 1. As requested in File No. NU-94-132, the City Council of the City of Kirkland hereby relinquishes any interest in the portion of right-of-way described as follows: A portion of right-of-way dedicated in the plat of Supplementary Plat to Kirkland, Volume 8 of Plats, Page 5, Records of King County, which abuts Lot 17, Block 235 of said plat; being identified in said plat as the portion of the east 30 feet of Cedar Street (now designated 114th NE) abutting said lot 17.

Passed by majority vote of the Kirkland City Council in regular, open meeting this 15th day of August, 1995.

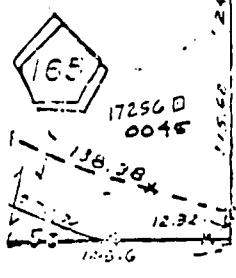
