RESOLUTION NO. R-4001

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KIRKLAND AUTHORIZING THE DIRECTOR OF ADMINISTRATION AND FINANCE TO CANCEL CERTAIN UNPAID AND DELINQUENT BUSINESS IMPROVEMENT AREA ASSESSMENTS AS UNCOLLECTIBLE.

WHEREAS, the Director of Administration and Finance has requested authority to cancel certain unpaid delinquent Business Improvement Area assessments as set forth in Appendix A to this resolution; and

WHEREAS, it appears that said accounts are uncollectible either because they are insolvent, the amount of the debt would exceed the cost of collection, or the account is paid in full and the amount remaining due the City represents the cost of collection; and

WHEREAS, sound business and accounting practices call for the cancellation of such uncollectible assessments; and

WHEREAS, the City Council finds that the Director of Administration and Finance should be granted authority to cancel said accounts;

<u>Section</u> 1. The Director of Administration and Finance for the City of Kirkland is hereby authorized to cancel as uncollectible those certain unpaid and delinquent Business Improvement Area assessments set forth in Appendix A to this resolution and by this reference incorporated herein.
