RESOLUTION NO. R-4049

A RESOLUTION OF THE CITY OF KIRKLAND AND NOTICE OF HEARING FOR THE VACATION OF AN UNNAMED RIGHT-OF-WAY LYING BETWEEN NE 108TH STREET AND 120TH AVENUE NE (FILE NO. VC-96-123).

WHEREAS, a petition has been filed with the City of Kirkland signed by the owners of real property representing more than two-thirds of the property abutting upon the hereinafter described portions of an unnamed right-of-way lying between NE 108th Street and 120th Avenue NE.

WHEREAS, it appears that the public interest of the City of Kirkland, Washington, would be served by holding a public hearing to consider the vacation of said portion of an unnamed right-of-way lying between NE 108th Street and 120th Avenue NE.

NOW, THEREFORE, be it resolved by the City Council of the City of Kirkland:

1) That a public hearing be held to consider whether the public interest and general welfare of the City of Kirkland will be served by the vacation of an unnamed right-of-way lying between NE 108th Street and 120th Avenue NE, situate in Kirkland, King County, Washington, and described as follows:

Those portions of the southwest quarter of the northwest quarter and of the northwest quarter of the southwest quarter of Section 33, Township 26 North, Range 5 East, W.M., in King County, Washington, described as follows:

Commencing at the west quarter corner of said Section 33; thence S 00°30'03" W, along the west line of said section, 30.00 feet to the south line of the north 30.00 feet of the northwest quarter of the southwest quarter of said Section 33; thence S 89°44'44" E, along said south line, 891.34 feet to the TRUE POINT OF BEGINNING; thence N 00°15'16" W 30.00 feet to the east west center of section line of said Section 33; thence N 89°44'44" W, along said east west center of section line, 3.79 feet; thence N 00°15'16" E 30.00 feet to the south line of Tract 46, Kirkland-Juanita Acre Tracts, as recorded in Volume 16 of Plats, page 63, records of said County; thence N 26°06'27" E 127.32 feet; thence S 89°44'44" E 11.04 feet; thence N 60°09'34" E 197.92 feet to a point of tangency with a 145.00 foot radius circular curve to the left; thence northeasterly along said curve, through a central angle of 39°36'00", an arc distance of 100.22 feet; thence N 20°33'34" E 59.23 feet to the westerly right-of-way margin of 120th Avenue N.E. (60 feet in width); thence S 00°59'24" W, along said westerly right-of-way margin 125.00 feet; thence N 89°00'36" W 12.30 feet; thence S 60°09'34" W 246.04 feet more or less to a point which bears N 34°58'13" W 330.57 feet to the TRUE POINT OF BEGINNING.

Containing approximately 20,241 square feet of 0.4647 acres more or less.
