A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KIRKLAND DECLARING AN EMERGENCY PUBLIC WORK FOR RELOCATION OF WATER MAIN AS AUTHORIZED BY KIRKLAND MUNICIPAL CODE SECTION 3.85.090.

WHEREAS, a relocation of a portion of the City's water system was required to accommodate improvements being made as part of a King County road improvement project No. 100187; and

WHEREAS, the City may have suffered a substantial loss by reason of the time required for following the regular purchasing procedures; and

WHEREAS, the City Manager authorized an emergency purchase pursuant to Kirkland Municipal Code Section 3.85.090 in order to prevent such a loss;

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Kirkland as follows:

<u>Section 1</u>. An emergency that could have caused substantial loss to the city existed on August 12, 1997, at the 12400 block of 132nd Place NE.

<u>Section 2.</u> The City Manager is hereby authorized and directed to take steps necessary to provide payment to Scoccolo Construction, Inc., for the services purchased by the City pursuant to Kirkland Municipal Code Section 3.85.090.

Subject: 132ND PLACE NE EMERGENCY WATER MAIN RELOCATION

King County is performing a major road reconstruction on 132nd Avenue/Place NE between NE 124th Street and NE 132nd Street. It has come to the attention of the County and their contractor that a required road grade cut at the southern portion of the project near NE 124th Street would result in Kirkland's water main in that area having a cover that would not meet minimum requirements. Therefore, it is necessary for the City to lower a portion of the water main by installing a new section of main adjacent to and lower than the existing main. In order to avoid a delay to the County's project, it is necessary to effect this scope of work on an emergency basis in lieu of the normal contracting procedures we use for CIP projects.

It is estimated that design/construction costs will be \$15,000 - \$20,000.

Your signature below authorizes an Emergency Purchase in accordance with KCM 3.85.090 enabling the Public Works Department to immediately negotiate with King County's contractor for performing the emergency water main relocation. A Resolution concerning this action will be presented to City Council at the September 2 regular meeting in accordance with RCW 35.22.620(6) and RCW 39.04,020.
