A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KIRKLAND RENAMING HOUGHTON NEIGHBORHOOD PARK, LOCATED AT 10811 NE 47th STREET, TO PHYLLIS A. NEEDY – HOUGHTON NEIGHBORHOOD PARK.

WHEREAS, Phyllis A.Needy served for 24 years as a member of the Houghton Community Council contributing numerous hours and energy to the community; and

WHEREAS, Phyllis A. Needy contributed significantly to the maintenance and preservation and improvement of the quality of life in Houghton; and

WHEREAS, the memory of Phyllis A. Needy will provide a shining example of community involvement, stewardship, loyalty and the best qualities of the neighborhood; and

WHEREAS, Resolution R-3215 sets forth policies and procedures relating to the naming of public property and facilities based upon several criteria, including naming after an individual who has given outstanding civic service to the park system, or who has been instrumental in the acquisition or development of critical park acreage; and

WHEREAS, both the Kirkland Park Board and Houghton Community Council has recommended to City Council the renaming of Houghton Neighborhood Park to Phyllis A. Needy – Houghton Neighborhood Park in honor of her commitment to the Houghton community; and

WHEREAS, the City Council finds that the recommendation of the Kirkland Park Board and Houghton Community Council meets the criteria established by Resolution R-3215 and that renaming Houghton Neighborhood Park to <a href="Phyllis A">Phyllis A</a>. Needy – Houghton Neighborhood Park is an appropriate way for the City of Kirkland to honor the contributions and efforts of Phyllis A. Needy while serving the Houghton community;

Now, therefore, be it resolved by the City Council of the City of Kirkland as follows:

- That certain neighborhood park now known as Houghton Neighborhood Park located at 10811 NE 47™ Street is hereby renamed Phyllis A. Needy Houghton Neighborhood Park in honor of Phyllis A. Needy former Houghton Community Council member.
- Section 2 The Department of Parks and Community Services is directed, pursuant to Resolution R3215, to install signage on the park site identifying the new name of the park.
