RESOLUTION NO. R-_ 4384

A RESOLUTION OF THE CITY OF KIRKLAND APPROVING THE ISSUANCE OF A PROCESS IIB PERMIT AS APPLIED FOR IN DEPARTMENT OF PLANNING AND COMMUNITY DEVELOPMENT FILE NO. IIB-02-52 BY LAKE EAST CHRISTIAN CHURCH BEING WITHIN A RS 12.5 ZONE, AND SETTING FORTH CONDITIONS TO WHICH SUCH PROCESS IIB PERMIT SHALL BE SUBJECT.

WHEREAS, the Department of Planning and Community Development has received an application for a Process IIB permit, filed by Lake East Christian Church, representing the owner of said property described in said application and located within RS 12.5 zone.

WHEREAS, pursuant to the City of Kirkland's Concurrency Management System, KMC Title 25, a concurrency application has been submitted to the City of Kirkland, reviewed by the responsible Public Works official, the concurrency test has been passed, and a concurrency test notice issued; and

WHEREAS, pursuant to the State Environmental Policy Act, RCW 43.21C, and the Administrative Guideline and local ordinance adopted to implement it, an environmental checklist has been submitted to the City of Kirkland, reviewed by the responsible official of the City of Kirkland, and a negative determination reached; and

WHEREAS, said environmental checklist and determination have been available and accompanied the application through the entire review process; and

WHEREAS, the application has been submitted to the Hearing Examiner who held hearing thereon at his regular meeting of February 11, 2003; and

WHEREAS, the Hearing Examiner after his public hearing and consideration of the recommendations of the Department of Planning and Community Development did adopt certain Findings, Conclusions, and Recommendations and did recommend approval of the Process IIB permit subject to the specific conditions set forth in said recommendation; and

WHEREAS, the City Council, in regular meeting, did consider the environmental documents received from the responsible official, together with the recommendation of the Hearing Examiner, as well as a timely filed challenge of said recommendation.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Kirkland as follows:

Section 1. The findings, conclusion, and recommendation of the Hearing Examiner and filed in the Department of Planning and Community Development File No. IIB-02-52 is adopted by the Kirkland City Council as though fully set forth herein, with the exception of Hearing Examiner Recommendation C.2.a, which is clarified as follows:

Submit a landscape plan showing that the unhealthy and dead vegetation within the landscape and parking buffers and parking islands will be replaced prior to final inspection. The plan shall also include the quantity, species, size, location of the replacement plantings, and a regular yearly maintenance schedule (see Exhibit A, Conclusion II.G.1). Furthermore, the landscape plan shall show how lights from cars parking in spaces 40, 41, and 42 along the south property line will be screened so they do not impact the adjacent house to the south.

- <u>Section 2.</u> The Process IIB permit shall be issued to the applicant subject to the conditions set forth in the recommendations hereinabove adopted and clarified by the City Council.
- <u>Section 3.</u> Nothing in this resolution shall be construed as excusing the applicant from compliance with any federal, state, or local statutes, ordinance, or regulations applicable to this project, other than expressly set forth herein.
- <u>Section 4.</u> Failure on the part of the holder of the permit to initially meet or maintain strict compliance with the standards and conditions to which the Process IIB permit is subject shall be grounds for revocation in accordance with Ordinance 3719, as amended, the Kirkland Zoning Ordinance.
- Section 5. Notwithstanding any recommendation heretofore given by the Houghton Community Council, the subject matter of this resolution and the permit herein granted are, pursuant to Ordinance 2001, subject to the disapproval jurisdiction of the Houghton Community Council or the failure of said Community Council to disapprove this resolution within sixty days of the date of the passage of this resolution.
- <u>Section 6.</u> A complete copy of this resolution, including Findings, Conclusions and Recommendations adopted by reference, shall be certified by the City Clerk who shall then forward the certified copy to the King County Department of Assessments.
- <u>Section 7.</u> A certified copy of this resolution, together with the findings, conclusions, and recommendations herein adopted shall be attached to and become a part of the Process IIB permit or evidence thereof delivered to the permittee.
- <u>Section 8</u>. Certified or conformed copies of this resolution shall be delivered to the following:
 - (a) Department of Planning and Community Development of the City of Kirkland
 - (b) Fire and Building Departments of the City of Kirkland
 - (c) Public Works Department of the City of Kirkland
 - (d) The City Clerk for the City of Kirkland.
